Guidelines to Provide of Relief to the Disaster Victims in a Disaster Emergency situation and to the People Evacuated from the Residencies due to Disaster Risk; and Restoration of Damaged Areas.

Your kind attention is drawn to item (iv) and (v) of para 03-1 of the circular No 03/2016 dated 30.12.2016 issued by the Department of National Budget on the above matter.

2. Accordingly I hereby amend the existing upper limit of providing emergency disaster relief/ cooked meals and dry rations as follows, considering the prevailing emergency situation and the urgent intercity of providing relief for the people who were affected by the recent disasters.
